For more than 15 years we have worked with a significant network of likeminded organisations to make a difference to the lives of children from a really young age. Now, every year we work with more than 65 place-based delivery partners across the UK to reach more than 110,000 children in more than 1,000 schools and since April 2023, thanks to a new individual digital subscription model, we are accessible even beyond that network, to all children and young people, wherever they are and regardless of how they are educated.

The opportunity

Becoming a Trustee of Children's University Trust is hugely enjoyable and rewarding. It comes with the opportunity to help shape the current and future direction of Children's University, to impact the lives of thousands of children and young people across the UK every year, to meet and work with people outside your own professional sector, and for both personal and professional development. It can also offer a lot of challenge and fun.

Here at Children's University Trust, our 7 Trustees hold overall legal responsibility for the charity. Our Board of Trustees is responsible for setting and overseeing the implementation of our strategy and for guiding the work of the charity in relation to areas such as finance, risk management, and organisational performance.

Our Trustees come from a wide variety of professional and personal backgrounds, and this makes for excellent discussions and sound decision making. Our charity benefits from our Trustees lived experience of their own education, learning, and enrichment, and we value all the varied contributions that Trustees bring. Children's University Trust has accessibility and inclusivity at its heart, so as a Trustee, you will join a Board where different viewpoints are welcomed and respected.

Children's University in a nutshell

Children's University encourages, tracks, and celebrates learning that takes place beyond the classroom. While curriculum time remains the focus of the formal education system, we know that time spent wisely beyond the classroom holds unlimited potential for life-changing experiences, skills development, and social mobility.

What we do

We run a long-established *Passport to Learning* programme that is proven to have a huge positive impact on children. We currently reach over 110,000 children each year through a consortium of more than 65 local delivery partners. These partners are typically universities, further education institutions and Local Authorities. All are not-for-profit and all are committed to equality of opportunity for the children in their area and encouraging limitless learning beyond the classroom. We also run a digital platform, *Children's University Online*, that works alongside our passport scheme offering children a safe and secure space to record their participation, while also providing schools, partners and policy makers with actionable data that helps inform and improve provision. In April 2023, we launched an individual subscription model which means that Children's University is now also accessible to all children outside our current network of delivery partners and schools, making Children's University truly accessible to all.

Why we're needed

With children only spending 9% of their waking life in a classroom by the time they turn 18, Children's University offers a framework for unlocking the potential held in the remaining 91%. It is a framework that complements and ties together existing extra-curricular initiatives, programmes and activities and enables educators to get a clear picture of availability of opportunity in their area as well as participation rates. An Education Endowment Foundation evaluation proved the impact that participation in Children's University has on closing the attainment gap between children on Free School Meals and their more advantaged peers. Right now, the rich-poor attainment gap in primary school is 9.3 months growing to more than 18 months at GCSE. Coivd-19 exacerbated that attainment gap like never before.

Research shows that young people's life chances in this country are still determined by the wealth of their parents and the social and cultural capital that this in turn brings. Research also shows that children develop better future life chances if they can extend their learning outside the classroom.

Where we work

Children's University is open to all but retains a focus on targeting areas of disadvantage and with children facing the most barriers to learning beyond school. Across the country Children's University works particularly well when focused on areas of social disadvantage. We know that by targeting these areas, Children's University can achieve the greatest social impact on the children with greatest need. We specifically target areas that are ranked highly in the Income Deprivation Affecting Children Index (IDACI) and areas where there is a

correlation between Free School Meals and poor access to Higher Education. We also target Opportunity Areas, the Government's Levelling Up Areas, and children facing non-geographic disadvantage through strategic partnerships with Local Authorities and Higher Education providers focused on greater inclusivity.

Numbers from Children's University Online



Every year c. 110,000 children take part in Children's University. In July 2023, there are 69,688 children with active accounts on our digital platform, Children's University Online.



There are 1,001 schools registered on Children's University Online.



There are 18,675 activities currently validated and available for children to access on Children's University Online.

Who we're looking for

We are looking for candidates who **fully support our charitable aims and objectives** and are passionate about our vision and mission, and really care about:

- the power and potential of informal education and informal skills development
- raising young aspirations
- closing gaps in educational opportunity, attainment, and outcome
- boosting the self-confidence, resilience, and cultural capital of children, regardless of their background and
- social mobility.

As a Trustee of Children's University, you will have a focus on creating opportunities for children and young people and you will act as an advocate for what we do. The children we work with come from a broad range of backgrounds. To best support all the children we benefit, our Trustees need to come from a wide range of backgrounds themselves. Therefore, we particularly welcome applications from a diverse range of people to reflect the diverse nature of our beneficiaries.

We're looking for candidates who will support but also know how and when to challenge the Executive Team and will have the vision, enthusiasm, and strong communication skills to influence Board decisions. All experience is valuable experience, so you don't have to have been a charity Trustee previously or sat on a Board before to apply.

The value of different experiences

Children's University Trust is committed to reflecting the communities we serve. We believe true diversity makes us a stronger organisation, which is why we're interested in who you are. Your lived experiences and your values are as important as your professional achievements. To reflect our commitment to diversity and inclusion, we particularly welcome applications from people who:

- are aged 18-26
- identify as disabled or neurodivergent
- have a broad range of experiences of working life (you don't need a university degree to be a Trustee)
- are ethnically diverse
- are from a working-class background
- are LGBTQIA+

Strategic Expertise

We need Trustees with the right skills and experience to guide and challenge the strategic direction of every area of the organisation. Every year, we review our Trustee Skills Matrix and determine the areas of expertise we need to add to our Board. This year, we are particularly looking for candidates who can deepen our expertise and understanding in one or more of the following areas:

- **Finance and accountancy** expertise, ideally a qualified accountant with an understanding of charity accountancy matters
- **Professional marketing** expertise, with experience of marketing strategy and industry knowledge
- **PR and communications** expertise, with experience in implementing strategic PR and communications plans to raise the profile of a brand and/or in broadening awareness of a brand's values and priorities and increasing its visibility across a wider audience.

You don't need to have experience in all areas to apply. We welcome applications from candidates who have relevant work and life experiences and have the passion to help Children's University Trust make a difference.

What we'll ask of you

Joining the Board as a Trustee is a hybrid position of online and in-person daytime meetings throughout the year (March, June, September, and December), including:

- 2 in person Board meetings of approximately 3 hours per meeting plus travel as meetings usually take place in London, Birmingham, or Manchester
- 2 online Board meetings of approximately 2 hours per meeting (via Zoom or Teams)
- Occasional extra meetings by teleconference if necessary
- Membership of a sub-committee

Beyond these key meetings, Trustees also make other valuable contributions and occasionally represent Children's University Trust at events. New Trustees will also need to complete our Trustee induction programme, which will include a mixture of face-to-face and online sessions to suit your schedule. This usually includes time spent with the Chair, Treasurer, CEO and Executive Team and members of the Children's University network.

We ask all Trustees to commit to a three-year term in the role. In total, a Trustee can stand for two consecutive terms, each of three years, before retiring.

All our Trustee positions are voluntary and so unpaid. However, we realise that being a Trustee can incur financial expenses such as travel or the cost of covering care. We are committed to ensuring that these costs are not a barrier to your application or to carrying out the Trustee role. Children's University Trust therefore reimburses its Trustees for reasonable expenses (according to the charity's expense policy), including all related travel and accommodation.

Responsibilities of Children's University Trustees

Trustees of Children's University Trust are jointly responsible for the overall governance and strategic direction of the charity, its financial health, its activities and developing the organisation's aims, objectives, and goals in accordance with the governing documents, legal and regulatory guidelines. The most important traits for a Trustee of Children's University Trust are:

- the desire and ability to act in the best interests of the Trust's beneficiaries
- integrity to do the right thing, even when that requires you to make tough decisions
- impartiality: you can make decisions that are fair and consider both sides of an argument
- empathy with our beneficiaries, so the decisions you make are based on delivering the best outcomes for children participating in Children's University
- the ability to absorb, understand and contribute to presentations, papers and spreadsheets presented to the Board.

The Board has a duty to make sure those appointed are eligible to be Trustees. The Board will reserve the right to make checks on eligibility.

Please note: The Charities Act disqualifies people from being Trustees if they:

- have unspent convictions for offences as set out in the Charities (Protection and Social Investment) Act 2016
- are undischarged bankrupts
- have made an arrangement with creditors and have not been discharged (this will include an IVA)
- are subject to a disqualification order under the Company Directors
 Disqualification Act 1986 or to an order made under section 429 (2) (b) of the Insolvency Act 1986
- have been removed from the Trusteeship of another charity by an order made by the Charity Commission of the High Court.

- and how you think you could help.

Please also provide the names, positions, organisations, and email addresses of two referees. References will only be taken once your express permission has been granted.

A note on eligibility

Please note that applicants must be able to show their eligibility to become a trustee as set out in The Charity Commission's The Essential Trustee guide.
